Yes

I use the facility daily and boat is moored there. As a family of 5 with 3 little kids, we are on the beach weekly. In the summer we are there almost daily for swimming, kayaking, floating etc., and picnicking.

2. What do you value most about the facility and wish to see preserved?

I value all of it and wish for it to remain as a local recreational facility. My favorite spot to go is the recreational area by the Quilcene Harbor Yacht Club. I prefer that area over the swim beach due to how shallow it is. The very gradual shallow slope is great because my kids can't swim yet and is safer for them to play there. I also value this location due to the yacht club's tremendous stewardship of the land. They do a fantastic job with regular beach cleanup, keeping the lawn and picnic area well manicured, and consistently pickup trash left by the general public. I worry about what would happen if they moved as the beach would become neglected and less comfortable to visit.

3. What do you dislike about the facility and wish to see changed?

I strongly dislike that there is no gas at the marina, that the bathrooms are closed and poorly maintained. There needs to be dumpsters added to the second boat launch area by the yacht club. I don't like packing my garbage out. I want the Port to water the lawn area in front of the yacht club for more comfortable picnicking. I'd like to see bathroom facilities installed to that area as well. It is a long walk to the marina with 3 little kids in tow.

4. What aspects of the facility are most in need of improvement?

Dredging the marina, bathrooms better maintained and open. The second boat launch dredged and upgraded for better launch capabilities. Currently only little fishing boats and kayaks can use the launch as it is so shallow.

5. What does the facility not have that the Quilcene community really needs?

Additional boat slips. There is currently not enough space for all the boaters and never any transient moorage available for out of area boating guests. We need Gas. It would be great to add a boat lift /haul out for larger boats or yachts for boat repair services. The community could benefit from employment a boat repair business would offer as well as a local boat repair service. Bathroom shower facility added to the area by the yacht club and dumpsters.

The Port has largely ignored previous recommendations from knowledgeable people. Consider that there was almost no implementation of the the recommendations for the Quilcene Marina in "Port of Port Townsend Assessment and Recommendations for the Marina Facilities" prepared by Waggoner Marina Services & Burrows Bay Associates in April of 2017.

So if the Port has not paid attention to knowledgeable people, one wonders why it would even consider asking the average Quilcene resident how to solve its problems. It is doubtful that any of us has a really good (let alone even basic) working knowledge of both commercial real estate and marina operations. We just don't have the training to understand the problems nor the skills and abilities to resolve them.

If you cannot figure this out for yourselves, get competent advice from experts in the field and then act on it.

1. Do you use the Port's Quilcene facility?

Yes

If yes, how often and what for?

We launch a boat at the ramp throughout the year depending on the fish and wildlife seasons for crabbing, shrimping and fishing. Over 20 times a year.

2. What do you value most about the facility and wish to see preserved?

I see a lot of value in the boat launch, the swim beach and the restroom facilities, and would like to see these preserved and upgraded

3. What do you dislike about the facility and wish to see changed?

When you launch a boat the walkway to the right that you have to walk down is not finished at all. It has large rocks on it and uneven gravel. It is very dangerous at anything close to a low tide. I fell on this ramp and was badly injured. At low tide there is no where to stand unless you stand on piles of rocks.

There were recent very low tides, 2 days with -4 foot tides. It doesn't appear that the bottom of the ramp was cleared off during this excellent opportunity to do so.

4. What aspects of the facility are most in need of improvement?

The walkway to the right of the boat ramp is very dangerous.

5. What does the facility not have that the Quilcene community really needs?

A safe way to launch a boat at the marina. With no safe walkway this launch is unsafe for most folks at lower tides. The ramp at the yacht club is ok in higher tides if you can avoid the cement blocks the oyster company has there.

6. What three (3) things would you like to see at the Port's Herb Beck Marina facility in the next five years? What about the next ten years?

5 years: install walking path next to launch in the marina, dredge the mouth of the marina, increase parking for trucks/boat trailers
10 years: maintain new walking path by launch, keep the mouth dredged and maintain the swim beach

Yes

Approximately 2x per month. Uses are various depending on the time of year. Fair weather uses are the boat ramp and swim beach. Throughout the entire year, I use the structure currently leased by the Quilcene Harbor Yacht Club as a recreational facility as well as a public use space for community meetings, activities, and social events.

2. What do you value most about the facility and wish to see preserved?

Public access to the Quilcene Bay waters and shoreline is vital to the community. A partnership with the Quilcene Harbor Yacht Club is a mutually beneficial arrangement that supports that access and mitigates repair and upkeep costs for the Port for that building.

3. What do you dislike about the facility and wish to see changed?

It feels run down and ill-maintained. Some of this is window dressing, but there is little pride of ownership evident.

4. What aspects of the facility are most in need of improvement?

The boat ramp is narrow, and that it is not a floating pier to launch from means that the part of the ramp that is just under the surface is more likely - especially because it is so narrow - to damage boats during launch and recovery.
