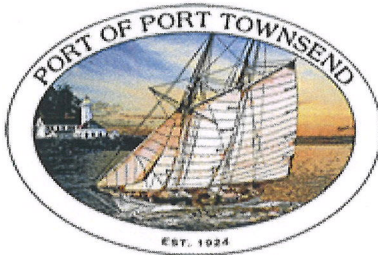

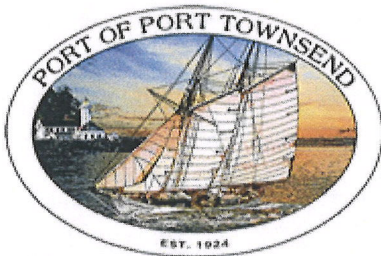

The current proposal is just aimed at annual licensees. Business moorage has the ability to sublease unlike any other class of moorage.

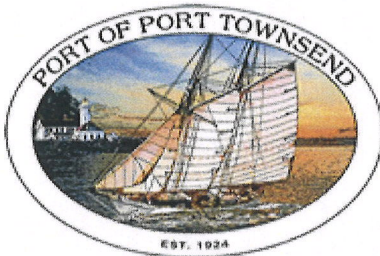
